For more than 60,000 years, Parramatta has been home to the Baramadaḡal and other Dharuḡ peoples, the Traditional Owners of the land we call the City of Parramatta today. The Baramadaḡal and other Dharuḡ peoples have cared for and nurtured the habitat, land, and waters for thousands of generations, and maintain an ongoing connection to Parramatta and its surrounding areas.

As a community, we can learn from the resilience and community spirit of First Nations people to best ensure a sustainable City for all. Parramatta has always been an important meeting place for the First Nations people, particularly the Parramatta River, which has provided life and vitality since the beginning of time (The Dreaming).

The name Parramatta is derived from the word Baramada /Burramatta or 'place where the eels lie down' (breeding location for eels within the Parramatta River).

City of Parramatta recognises the significance of this area for all First Nations people as a site of early contact between the First Australians and European Colonists, and Parramatta remains an important meeting place for the First Nations community.

First Nations people continue to play a vital role in the ecological, economic, social and cultural life of Parramatta, while maintaining a distinct culture built on the principles of Caring for Country, the primacy of family, and the dignity and governance of Elders.

At City of Parramatta, we aspire to a future where the cultures, histories and rights of all First Nations people are understood, recognised, and respected by all Australians. City of Parramatta is committed to playing an active role in making this future a reality. City of Parramatta is proud to acknowledge the ongoing stewardship of Country by Dharug and other First Nations people and to celebrate their enduring wisdom, strength, and resilience.

MESSAGE FROM THE LORD MAYOR

AS AT 30 JUNE 2024

I'm proud to present our 2023/24 Annual Report.

As I prepare to close the book on a 25-year career on Council, I can hand-on-heart say that there has not been another 12-month period where we've made as much progress as a City.

We've delivered big infrastructure, big events and big ideas and many, many small projects that will make a big difference in people's everyday lives.

The year was bookended by milestones for two of the biggest infrastructure projects in our history – the completion of our Parramatta Aquatic Centre (PAC) and the first look at designs for our new Riverside Theatres.

PAC is so much more than just a pool. It's been an investment in the well-being of our community – a place they can learn to swim, train for greatness and unwind just a stone's throw from our CBD. It's even got me going to spin classes!

We also took a major step towards our reimagined Riverside Theatres, announcing the winning design. The new design and significantly increased capacity will help establish the venue as a world-class performing arts centre that will supercharge our visitor economy.

While we're excited about future builds, we also took steps to preserve one of our City's oldest landmarks – Parramatta Town Hall – and equip it with modern audio and lighting features. The restored Town Hall adjoins our iconic civic, cultural and community hub, PHIVE, connecting the City's past with our present.

Throughout the year, we also completed:

- > A \$12.9 million upgrade of Charles Street Square that provides a first-class arrival experience and gathering place for locals and visitors;
- > The \$19 million Alfred Street Bridge, part of a growing network of active transport links that is making the City easier to navigate for pedestrians and cyclists;
- > Plans for the next stage of Civic Link which will run from Parramatta's CBD to the River.

Over the past 12 months, we've spent a lot of time thinking about our City's future.

Our *Parramatta 2050* vision is unlike anything Council has done before. It seeks to chart a course for Parramatta's continued transformation into a global City over the next 25 years.

We want Parramatta to be where it’s at – day or night.

Our new Late Night Trading Development Controls set a new benchmark for the entirety of Sydney and sends a signal to businesses that if you want to be part of a growing night-time economy, Parramatta is the place to be.

Our events continue to grow from strength to strength. Record crowds of more than 180,000 people flocked to the City over four nights in October for our signature food, art and music festival, Parramatta Lanes, with celebrations for New Year’s Eve, Australia Day and Lunar New Year also a major drawcard. We also invested in neighbourhood events like our outdoor cinema series which saw hundreds of families gather in local parks to enjoy Hollywood hits on the big screen.

Through our Community Grants Program, we invested more than \$540,000 in helping community and cultural organisations, volunteer groups, sporting clubs, and social enterprises. We are proud to be able to invest back in the people and organisations who invest so much of their own time and energy in making our community special.

Council was pleased to welcome 3,622 new Australians at 12 citizenship ceremonies throughout the year. We are proud they have chosen Parramatta to make their home.

I want to thank my fellow Councillors for their passion and energy. We debate issues robustly at times but we are all driven by a common desire to make our community stronger. I’m proud of what we have been able to achieve together.

I want to thank our Chief Executive Officer, Gail Connolly PSM, her hard-working Executive Team and the many dedicated staff for their service to our community.

I am incredibly proud to have played a part in shaping this great City – and to have worked alongside so many people who have are just as passionate about Parramatta.

I look forward to watching our great City thrive into the future.

MESSAGE FROM THE CEO

AS AT 30 JUNE 2024

This year we've laid the foundations for an even stronger future for our City.

Our investment in services and infrastructure ensured we're not just delivering on the needs of our community now but building the capacity and opportunities they deserve long-term.

Here are just a few highlights of the past year:

> We made a splash with our new Parramatta Aquatic Centre (PAC).

Nestled into the surrounds of Parramatta Park, the \$88.6 million centre opened in September 2023 and has provided our community a year-round destination to swim, workout and relax. Since then, PAC has attracted close to 500,000 visits, more than 2000 swim school registrations and even starred in a fashion shoot in Marie Claire magazine.

And it's not just locals that love it. In June 2024, PAC was recognised at the NSW Architecture Awards with the State's highest honour for public architecture, the Sulman Medal.

> We re-opened the newly restored Parramatta Town Hall.

For Council, the restoration of Town Hall has been a \$30 million investment in preserving one of our community's most loved buildings – and turning it into a state-of-the-art venue.

It also marked the final piece in the puzzle of the transformation of Parramatta Square in our City's heart.

> We raised the curtain on what a reimagined Riverside Theatres will look like.

In May, we announced the winning design for the redevelopment of Riverside Theatres.

It promises to create a new architectural landmark in the City that honours our First Nations heritage and will be an anchor of our growing arts and culture precinct. Construction on the reimagined Riverside will begin next year and give us double our existing theatre capacity and a world-class performing arts centre that will attract the very best in live performance from Australia, Broadway and the West End to our City.

> We launched our landmark First Nations Strategy

Parramatta has always been an important gathering place for First Nations people – and we want that to continue.

This strategy reflects years of work with First Nations people and builds on the legacy and learnings of Council's Stretch Reconciliation Action Plan.

It's the best in the country and represents our commitment to continue fostering meaningful and respectful relationships with Dharug and other First Nations people and developing partnerships built on action.

> We worked harder to understand the needs of our community.

Over the past year, we've run two community workshops in each ward, giving hundreds of local residents a chance to have their say on neighbourhood priorities and the broader vision for our City.

This feedback and our annual Community Satisfaction survey has been invaluable in shaping Council's priorities and the development of a new plan to improve our service delivery and make it easier to interact with us.

> We're planning for the future

Council continues to punch above its weight on housing, exceeding its 2021-2026 targets by 9% and plans are already in place for more than 75% of our target to 2029. Our new housing target - backed by the ambitious jobs target of 150,000 new jobs outlined in the City's Parramatta 2050 Vision - supports the need for continued investment in infrastructure and transport including two additional Metro stops between Parramatta and Sydney Olympic Park.

We also approved 17 regionally significant applications that will bring with them increased infrastructure such as roads, parks and a new town centre at Melrose Park.

> We're partnering with organisations to realise our City's potential

Council recognises the potential to work with partners to realise shared objectives that make our community stronger.

In line with this, Council this year began a three-year partnership with the Parramatta Eels that is delivering free rugby league clinics to local kids, building participation and inclusion for young girls in multicultural communities and supporting a new scholarship for women in Western Sydney.

The new partnership also seeks to grow the reputation of Parramatta as a global visitor destination, with the City's destination marketing brand "Parramatta - Where It's AT" featured on the Eels' NRLW playing jersey and in game day signage and advertising.

Parramatta is also investigating partnerships with other major players in the City who share our vision for Parramatta.

> We prepared a vision to guide our journey to 2050.

Since June 2023, Council has been working on a strategy to guide the evolution of our City over the next 30 years.

Parramatta 2050 represents our pitch to the world – a plan to see our City recognised internationally as a place where people gather to share their ideas and collaborate, create firsts and where great ideas can build momentum.

The feedback from community and stakeholders has been instrumental in shaping the final vision.

I want to thank the community and organisations who work with us every day. Collaboration is a hallmark of the way our Council does business and it's heartening to have so many people share our commitment to seeing the City of Parramatta thrive. Their feedback, guidance and willingness to back our initiatives is invaluable.

I want to thank our Lord Mayors and Councillors for their continued support and their enthusiasm and commitment to making Parramatta the best place to live, work and invest.

Finally, my sincere thanks goes to our staff who come to work every day seeking to do their best for our community. Their passion for putting people and community first ensures that we will continue to build a great global City.




Under the NSW Local Government Act 1993, all councils are required to take a rigorous approach to strategic planning, financial management and statutory reporting.


Accordingly, our City is increasingly recognised as a leading destination for business, education, research, art and culture, dining, and nature and heritage experiences.







OUR COUNCILLORS

AS AT 30 JUNE 2024

The City of Parramatta is represented by Councillors who have been elected for a 3-year term until September 2024. Our Councillors are elected by residents and non-residents across five electoral areas known as wards, with the Lord Mayor and Deputy Lord Mayor elected by the Councillors.

Councillors act as a link between the community and Council, making decisions and policies guided by the Local Government Act (1993) and other relevant policies.

Councillor Sameer Pandey was elected Lord Mayor at the Extraordinary Council Meeting of 22 May 2023, and Councillor Cameron MacLean was elected Deputy Lord Mayor at the Ordinary Council Meeting of 13 June 2023, both elected until 25 September 2023.

Councillor Pierre Esber was elected Lord Mayor and Councillor Dr Patricia Prociv elected Deputy Lord Mayor at the Extraordinary Council Meeting of 25 September 2023. Lord Mayor Esber and Deputy Lord Mayor Prociv will hold the positions until the next local government elections to be held in September 2024.

Donna Davis MP and Dan Siviero resigned from their role as Councillors for the City of Parramatta on 23 January 2024 and 14 June 2024 respectively.

GOVERNANCE

Government in Australia is comprised of three tiers: federal, state, and local. The City of Parramatta is one of 128 local governments in New South Wales operating in accordance with the Local Government Act 1993 (the Act).

The Act sets out a system for elected members to form a Council, describing the functions of local governments, providing for the conduct of elections and polls, and providing a framework for the administration and financial management of local government, including accountability and transparency.

Governance at Council

All Council operations are implemented within a rigorous framework of governance policies and procedures. This helps to ensure that decision-making is transparent and accountable, and organisational activities are free from fraud and corruption with a focus on providing effective leadership and administration.

Council has a dedicated Secretariat team that are responsible for providing a high level of administration services with respect to the elected Council and Committee meetings, to ensure Council services are transparent, accountable and free of conflict.

The Code of Meeting Practice (The Code) governs the way in which Council meetings are conducted. The Code applies to all meetings of Council and


Committees of which all members are Councillors. The Code allows for public participation at Council Meetings.

Members of the public may make an application to address Council at a Council Meeting. Council allows a maximum of five speakers at each Council Meeting.



Council Meeting Statistics





Councillors are required to declare and manage any conflicts of interest that may arise in matters being considered at meetings of the Council and committees of the Council in accordance with Council's Code of Conduct. All declarations of interest raised at Council Meetings and how the conflict of interest was managed are recorded in the minutes of the Council meeting at which the conflict was raised.

> Register of Council Decisions

Council, as the governing body, is the decision-making authority on matters of legislative, strategic, policy and community importance. Decisions of the governing body are made at Council Meetings, and the decisions are recorded in the minutes of the Council Meetings.


AUDIT AND RISK

City of Parramatta Council established the Audit Risk and Improvement Committee (ARIC) in accordance with Section 428A of the Local Government Amendment (Governance and Planning) Act 2016. ARIC is an independent advisory committee that operates under its own designated Charter, to promote good corporate governance by providing independent objective assurance and assistance to Council.

The Committee consists of two Councillors and three independent external members, of which one is the external Chairperson. The Committee meets five times a year with four ordinary meetings and one special meeting to consider Council's Annual Financial Statements.

INTERNAL AUDITS

Audits provide independent, objective assurance designed to add value and improve Council's operations. An internal audit contractor also ensures independence and autonomy from City of Parramatta's management and enables specialised knowledge and skills to be procured to conduct audits.



The Internal Ombudsman Shared Service (IOSS)

The Internal Ombudsman Shared Service (IOSS), shared between City of Parramatta, Cumberland City and Inner West Councils, is an ‘independent ear’ for the community, Councillors, Council staff and Council stakeholders. The IOSS undertakes the investigation of complaints and assists Councils with prevention and education activities.

The IOSS assists member Councils to:

- Promote a high standard of ethical conduct and decision-making
- Improve administrative conduct and procedures
- Identify areas for improvement in the delivery of services to their communities
- Ensure they are acting fairly, with integrity and in their communities’ best interest
- Deal effectively with complaints
- Work to improve their complaint handling systems
- Strive for a corruption-free organisation.

IOSS operations are underpinned by the principles of procedural fairness, accountability and transparency.

Over the last 12 months, the Internal Ombudsman Shared Service (IOSS) delivered 180 activities for the City of Parramatta, one of three Councils within the IOSS service. This included the assessment, management and response of 123 complaints, an increase on the year prior. The IOSS developed and delivered training - undertaking 20 training activities across the 12 months to improve the awareness and knowledge of Council officials in relation to the Public Interest Disclosures (PIDs) framework and to increase overall awareness of IOSS functions. Prevention activities slightly decreased given a reduction in requests for advice.

In the year ahead, the IOSS will strive to continue to deliver a high standard of service to all member communities and continue to work to increase accessibility of the service and efficiencies in delivery. The IOSS will assist Council with the newly elected Council body. The IOSS will continue to deliver quarterly Public Interest Disclosure officer training to ensure Council meets its statutory training requirements under the Public Interest Disclosure Act 2022 which came into effect from October 2023.



OUR PEOPLE



The City of Parramatta continues to be one of the fastest growing local governments in New South Wales.

To ensure we are delivering to our community and strategic objectives, we continue to invest in our leaders, future talent, and in developing an early careers program. We are prioritising employee connectedness and engagement by focusing on Diversity, Equity and Inclusion (DEI), and providing clarity and structure in our policies and procedures.

OUR CURRENT WORKFORCE

City of Parramatta is committed to ensuring our workforce can deliver the strategic objectives set out in our Community Strategic Plan.

As at the 30 June 2024, City of Parramatta had 1498 employees engaged in paid work, 968 of which are permanent full-time employees, 102 permanent part-time employees, and 279 casuals.



RECRUITMENT

During the 2023/24 financial year, 18,615 applicants applied for advertised positions at City of Parramatta. This is 4,455 more than the previous year and shows a relatively steady increase based on an increase of 5,000 in 2022/23. 40% of applications were via Seek,

12% via LinkedIn, and 27% direct from Council's website careers page. Advertised positions in customer service and libraries attracted the highest number of applications. Recruitment is primarily supported by an in-house team.

AGE AND GENDER PROFILE

The age profile of our workforce remains relatively steady, consistent with other sectors and the general population. Our average age is 43 years old, with our greatest number of employees aged between 45 and 59.

The City of Parramatta has seen a rise in gender equality across its workforce with an increase

in our female workforce from 49% last financial to 50% for 2024 with greater representation in leadership roles. Led by a female CEO, women represent 29% of our executive leadership and 21% of our senior leadership; an increase of 4% in female representation. There has been an increase of 8% in female representation in middle management, and 5% in frontline leadership.

DIVERSITY

Council continues to implement its Diversity, Equity & Inclusion Strategy, 'We Belong', focusing on attracting, developing, and retaining diverse talent while creating an inclusive workplace.

Our Employee Resource Groups (ERGs) sponsored by the executive team continue to raise awareness across Gender, LGBTQIA+, Disability, Early Careers and Veterans and now include a First Nations ERG.

Action plans from the Disability, Inclusion Action Plan 2022-2026 are on track including the roll out of Inclusive Recruitment training and Hidden Disability training available to all employees. Actions from the First Nations Strategy 2024-2029 are also progressing on track with a key focus on delivering cultural competency training and skills and development programs.

CULTURE AND EMPLOYEE ENGAGEMENT

The City of Parramatta encourages all employees to have their say on our workplace culture – what is working well and areas for improvement – through formal surveys. The results shape the actions planned to improve the working experience.

As a result of last year's survey, we have reviewed our leadership development program and introduced an internal program that focuses on specific development areas highlighted in the engagement feedback. These programs, along with Learning Fest and Leadership forums provide opportunities to continue to uplift the capability and engagement of our leaders.

LEARNING AND DEVELOPMENT

Council continues to implement the Learning & Development Strategy 2023-2026, embedding a culture of learning through initiatives such as Learning Fest, a biannual skills and development program available for all staff. In November 2023 Learning Fest focused on the 'Customer Experience' and in May 2024 on 'Leading People Effectively' and 'Tools to Empower You'.

In 2023/24 the Evolve Leadership program was completed by 69% of leadership staff and aspiring leaders. The Evolution 1.0 follow up program was completed by 346 staff covering a range of modules such as safety, change inclusive leadership, coaching and performance.

WORK HEALTH AND SAFETY

Our Health & Wellbeing Action Plan has delivered a range of programs throughout 23/24 to support our staff. We prioritised preventative health services by delivering flu vaccinations, manual handling training, and skin checks. At risk workers were also offered Tetanus & Hepatitis vaccinations. Employee Assistance Program (EAP) remained available to all staff offering professional services and mental health support including but not limited to career coaching, depression and anxiety counselling, financial counselling and nutritional consultation.

The following initiatives are also available to staff to improve health and enhance wellbeing;

Fitness Passport gym memberships, wellbeing webinars and access to a free digital Health & Wellbeing app. Council's commitment to Mental Health First Aider training has maintained our recognition by MHFA Australia.

In 23/24 Lost Time Injury (LTI) and Medically Treated Injury (MTI) count is trending down. We saw an increase of reporting on worker and patron incidents, injuries and near misses with a total of 716 events reported (386 worker incidents and 330 patron incidents) in 23/24. Continuous improvement will prioritise review and analysis with our lead indicators on reporting timeliness, contractor compliance and corrective actions.

Parramatta Aquatic Centre Opening

The Parramatta Aquatic Centre (PAC) is a partnership project with the NSW State Government. This multi-purpose and sustainable facility provides a new social space for the community, promoting health and wellbeing for people of all ages, abilities, interests, and backgrounds.

Opened on 25 September 2023, PAC covers 40,000 square metres and includes a 50m, 10-lane outdoor heated pool

with seating; a 25m indoor recreational pool; an indoor learn-to-swim pool; an indoor splash play area; multipurpose community rooms; spa and sauna facilities; fitness centre; café; and up to 180 parking spots.

Since opening the centre has seen more than 20,000 people attend swimming lessons, 4,000 school children attending swimming carnivals, and over 2,000 swim school program registrations.

A Commitment to Affordable Housing

Housing affordability is a critical issue for Parramatta and Greater Sydney. In 2023, Council developed an Affordable Housing Action Plan which identifies direct actions and advocacy positions that Council will take towards improving housing affordability in the LGA during 2023-2025.

In May 2024, Council exhibited amendments to the Affordable Rental Housing Policy, which addresses the operational management of Council-owned affordable rental housing properties and complements the Affordable Housing Action Plan.

Sport, Open Space and Recreation

Throughout 2023-24 Council progressed a number of key sporting and community infrastructure projects through to concept and detailed design phase. These upgrades are funded under The NSW Government's Western Sydney Infrastructure Grants Program and aim to provide high quality sporting and community facilities at locations throughout the LGA such as Somerville Park in Eastwood, Doyle Ground in North Parramatta, Max Ruddock Reserve in Winston Hills, Sue Savage Reserve in Toongabbie, West Epping Park Dog Off Leash Area and Kilpack Park in Carlingford.

In April 2024 Council placed the Sportsground Allocation Policy on exhibition. This policy aims to ensure that Council will allocate the use of its Sportsgrounds in a systematic approach which aligns with Council's broader Sportsground Strategy and values, including to actively contribute to the health, wellbeing, equality, and inclusion of the whole community.

In 2024, City of Parramatta also signed a three-year partnership with the Parramatta Eels to help cement the City's reputation as the home of sport, drive visitation and economic growth and build capacity in the community.



The Social Sustainability Strategy 2024–2033

In June 2024 Council endorsed The Social Sustainability Strategy 2024-2033. This is Council's ten-year vision for an equitable and resilient Parramatta where residents are safe, socially connected, and have what they need to live

with dignity and to thrive. It establishes five priorities which will guide decision making in how Council plans and delivers community infrastructure, services, and programs.

Meals on Wheels

During 2023/24 our Meals on Wheels volunteers have contributed more than 2,107 hours supporting participants and delivering more than

27,719 meals to ensure that vulnerable members of the community have access to healthy, nutritious meals.

Active Parramatta

Active Parramatta is a Council initiative that provides free and affordable health and wellbeing programs that cater to people of all ages, abilities and backgrounds both online and in person. This past year The Active Parramatta Van offered over 130 free programs such as Gentle Exercise, Mobility Flow and Holistic Fitness to over 9,000 participants. The Health & Fitness programs including Zumba, Pilates, yoga, boxing and circuit training attracted over 1018 registrations.

Council's school holiday program - the largest free school holiday program in NSW, offered 161 activities with over 2,400 participants.

Council also partnered with the Australian International Sports Organisation to provide an eight-week multi-sport afterschool program informed by research from Western Sydney Health. Utilising the Active Kids Voucher program 653 children participating in this program.





Disability Inclusion Action Plan

City of Parramatta is delivering on key community outcomes identified in the Disability Inclusion Action Plan 2022-2026. Commitments over the last year include working with Autism Spectrum Australia (ASPECT) to create Autism friendly spaces and services, Auslan interpreted Story Time sessions at Council libraries, three digital wayfinding kiosks installed in the Parramatta CBD and an access audit completed for all playgrounds across the LGA to inform Council's accessible playground framework.

Council is also working with the Australian Network on Disability to develop a Workplace Adjustment Policy, and the Parramatta Aquatic Centre (PAC) is working to increase access for people with disability by providing opportunities for free trials and identifying quiet spaces and times for people who may struggle with sensory overload.

The Parramatta Bike Plan

The Parramatta Bike Plan was endorsed by Council on Tuesday 11 June 2024. This Plan looks at opportunities to invest in new and existing cycleways and create a better user experience for the community including:

To enhance the productivity and liveability of Parramatta through an increase in cycling, helping foster healthy and connected residents, workers and visitors.

For cycling to be safe and perceived as a safe and attractive option for all members of the community, for those aged 8 through to 88.

To increase the proportion of people cycling in Parramatta to 5% of all trips to work, and 10% for those ending in the CBD

Alfred Street Bridge

In October 2023, a new gateway into the City of Parramatta was officially opened. The Alfred Street Bridge is both a distinctive landmark and an important piece in a growing network of active transport links, which will make it easier for pedestrians and bike riders.

The 4.5-metre-wide, 200-metre-long bridge spans the Parramatta River between James Ruse Drive and Gasworks Bridge.

It provides the City's growing population with a convenient, safe and scenic connection over the river, directly to the Stage 1 Parramatta Light Rail.

The \$19 million project, co-funded by Council (\$7.5million) and the NSW Government (\$11.5 million), is Australia's first true diagonal arch bridge.

Parramatta Light Rail Advocacy

Council's successful advocacy to the NSW Government to progress Stage 2 of the Parramatta Light Rail resulted in the Department of Planning Housing and Infrastructure providing planning approval for Stage 2 in February 2024.

Stage 2 will connect Stage 1 and the Parramatta CBD to Sydney Olympic Park via Camellia, Rydalmere, Ermington, Melrose Park and Wentworth Point.

Enhancing Pedestrian and Cyclist Networks

Plans are underway for four new pedestrian and cyclist projects - Bennelong Parkway Bridge and Paths, Toongabbie to Westmead Corridor, Kleins Road Corridor, and the Wilderline to Duck River Paths. These plans were presented to the community for feedback March and April 2024 and include proposals for new footpaths and bike paths, safer crossing facilities, boardwalks and bridges to improve pedestrian and cyclist infrastructure.

Pedestrians and cyclists travelling through Rydalmere have a safer connection to Parramatta with the completion of the raised combined pedestrian and cyclist crossing on Brodie Street.

This project is funded by the NSW Government's Parramatta to Sydney Foreshore Link.

Council has also progressed the George Street East Pedestrian and Cyclist Paths through the detailed design phase and the Norwest T-Way Shared Path and Ermington Foreshore Stage 3 into the construction phase which will begin in later 2024.







First Nations Strategy 2024-2029, WARAMI & Ngana Birrung

City of Parramatta's relationship with Dharug and the First Nations community reached a new milestone with completion and launch of the ground-breaking First Nations Strategy at the City's meeting place, Parramatta Town Hall on 2 May 2024.

This Strategy was developed in consultation with the First Nations community, service providers, staff and the wider community and is focused around five pillars: social justice, cultural leadership, social cohesion, celebration, and accountability. It embodies a unique framework

specific to the City of Parramatta, demonstrating Council's commitment to the fundamental principles of the Uluru Statement of the Heart: **Voice, Makarrata (meaning 'Treaty' in Yolngu), and Truth.**

WARAMI is Council's overarching festival for First Nations events and programs including Sorry Day, YinByalla 'Truth Talking'; for National Reconciliation Week, and Burramatta NAIDOC. **Ngana Birrung** was also held in March 2024 which unites First Nations musicians from across the Country and provides a platform for local artists.

Parramatta Lanes 2023

From 11 - 14 October 2023 Parramatta Lanes attracted more than 180,000 visitors across 15 laneways and roof top car parks, offering a range of street food, live music, and cultural experiences. Local restaurants, food trucks, and pop-up stalls showcased multicultural cuisines, and 120 musicians performed, with more than fifty per cent

from Western Sydney. Three public artworks were featured including Lawrence Liang's Bloom sculpture illuminating St John's Lawn.

A special 'Festival of Lights' event was also held on Saturday 14 October to celebrate the sights, sounds and colours of the South Asian community.

Cultural Celebrations

Each year Council celebrates its cultural diversity through a range of programs and events. In February 2024 Parramatta came alive with artinstallations, street food, live entertainment, cultural workshops and performances to celebrate Lunar New Year. The event also provided insight into history and culture through the ancient art of traditional Chinese

calligraphy, lanterns, a wishing ree, traditional tea sampling and roving dragon and lion dances.

Diwali is also a significant celebration with almost 29,000 Indian-born residents in Parramatta. Council supported a range of community-led celebrations such as the Little India Diwali Celebration in Harris Park on 18 November 2023.



Riverside Theatres Redevelopment Project

Riverside Theatres is the premier performing arts venue in Western Sydney. In May 2024, the highly anticipated winning design for the redevelopment of Riverside was announced. Featuring a 1,500 seat Broadway-style lyric theatre with First Nations inspired interiors, the iconic design also includes the refurbishment of the iconic 760-seat Riverside Playhouse Theatre, construction of an all-new 430-seat 'Black Box' drama/performance theatre, an all-new

80–100 seat digital development studio / digital cinema and enhanced public spaces, foyers, food and beverage and function spaces.

This redesign will help establish the venue as a world-class performing arts centre, that will attract major Australian and international works to Parramatta whilst also creating a space where everyone feels welcomed and inspired and which embodies our commitment to cultural inclusion and creative excellence.

Parramatta Town Hall

Parramatta Town Hall has a rich legacy serving as a key community gathering space since 1883. The recent \$30 million upgrade includes the restoration of original features as well as the addition of a light-filled, modern glass atrium that directly opens onto the vibrant Parramatta Square, and integrates with PHIVE, Parramatta's new community, cultural and civic hub.

The seamless blend of heritage architecture and contemporary design, demonstrates our ongoing commitment to conserving heritage and embracing a new and exciting phase in the City's transformation.

Programs at PHIVE

Programs at PHIVE have continued to be popular amongst children and families with school holiday workshops and hands-on activities booking out. 'Creature', an interactive light display, and 'Beetle', a physical storytelling performance, provided low

and no-cost opportunities for families in Western Sydney to engage in arts and culture experiences. Sea of Light was a highlight of the events and programming calendar with 30,241 free tickets being snapped up by local families.




We value and care for our environment.





Environmental Sustainability Strategy 2024–2033

Throughout 2023/24 Council continued to review the draft Environmental Sustainability Strategy 2024–2033. This is Council's ten-year vision that focuses on regeneration, resilience and climate

action that will guide Council's decision making and encourage environmental actions and outcomes that bring people and nature together.

City for Nature

As a city for nature, Council has worked with partners and the community to give the city a green make-over including:

- > **Greening Parramatta Program:** In partnership with NSW State Government, over 1900 trees have been planted in streets and parks, prioritising areas vulnerable to urban heat.
- > **Parramatta Light Rail Tree Planting:** In partnership with Transport for NSW, more than 937 trees are being planted to replace those removed during the light rail construction.
- > **Community Tree Champions:** A volunteer program engages residents in tree planting, with 70+ Tree Champions fostering community ownership.
- > **National Tree Day:** Council hosts a major tree-planting event, with volunteers planting 10,000 plants each July.
- > **Bushcare:** volunteers have contributed 9,267 hours to weed removal, habitat restoration, and tree planting in bushland reserves.
- > **Canopy Plan:** For Parramatta to be a great city, it needs truly great trees. Throughout 2023/24 Council developed a report on progressing the Canopy Plan. The report included a range of preliminary actions that establish first steps towards improving organisational capacity in tree delivery and management.

These initiatives aim to create a greener and more sustainable Parramatta, with active community involvement in preserving and enhancing the natural environment.

Parramatta River Flood Study

The Parramatta River Flood Study was endorsed by Council in June 2024. City of Parramatta will now share the endorsed 2024 Parramatta River Flood Study and modelling with stakeholders and the community and begin work on the

Draft Floodplain Risk Management Study and Plan. This will explore options to reduce flood risk to property and will consider works such as levee banks, flood detention basins, house raising, property acquisition and community education.

eDNA survey

Hundreds of species could be identified as Parramatta becomes one of the first NSW councils to use new Environmental DNA (eDNA) testing as part of its biological survey of waterways to improve its local biodiversity.

All animals and plants shed fragments of their DNA into the environment, which is then washed into creeks and rivers. This new technique takes a forensic investigative approach to analysing the DNA samples and cross-matching them to a database.

Sustainability at the PAC

The Parramatta Aquatic Centre (PAC) has been designed with environmental performance front of mind. From sourcing ecological materials to water harvesting and alternative energy options, Parramatta's newest community facility strikes the right balance between having the power to treat and heat water, keep the lights on and maintain a comfortable temperature, and delivering on Council's sustainability mission to do more and use less.

Some key features include rooftop solar panels, expansive skylights made from a lightweight material Ethylene tetrafluoroethylene (ETFE) that helps improve the buildings energy consumption, three rain gardens to collect stormwater and an integrated centralised plant, located at the basement of the building, that will deliver waste, heat and energy efficiencies.

FOGO

Food Organics and Garden Organics (FOGO) is a new way to recycle your food scraps and garden waste and reduce landfill at the same time. Council staff have been actively engaging the community with a range of educational activities and resources on-line and in-person to ensure our residents are up to date on the FOGO roll-out

Council also has a dedicated FOGO customer service team, engaged additional staff to assist the process and revised all collateral to ensure consistent messaging on FOGO across the LGA.

FOGO in Parramatta is due to commence its first phase in November 2024 for residents in houses, town houses and unit building with 30 dwellings or less. The second phase for larger building will commence in 2025.





Charles Street Square

With the \$12m+ transformation of Charles Street Square now complete and officially opened on 27 November 2023, Parramatta Quay welcomes residents and visitors to a new riverfront gathering place that connects people to Parramatta's unique stories.

Celebrating the point where salt water and fresh water meet, Charles Street Square now offers a distinctive arrival for ferry passengers with easy-to-navigate ramps and stairs making connections between the Parramatta River and the CBD accessible to all.

City of Parramatta's design for Charles Street Square draws inspiration from the curved geometry of the river, the surrounding landscape, and the site's unique history. This vibrant public space now offers a wide riverside promenade, an amphitheatre, garden terrace and City square.

Cultural heritage aspects form part of the visitor experience, with opportunities to scan small QR codes inlaid into seating to learn more about the people, places and events that have shaped Parramatta over time.

Parramatta Artist Studios Relocation

Parramatta Artists' Studios is home for creative production in Western Sydney, providing a contemporary and collaborative art space, which connects artists with community and contributes to a vibrant culture.

Through our supported studios, as well as our digital residencies, we offer tenancies, residencies, career development opportunities and community connected programs.

PAS Granville opened in May 2024, and together with the Rydalmere studios offers fourteen new spaces for artists. PAS is committed to providing a culturally safe and uninterrupted space for First Nations artists and community members, offering a space for them at the new Granville location.

Since 2006 PAS has provided hundreds of aspiring and recognised artists with opportunities to develop their studio-based practices, a rarity across Sydney.

We have a growing community of alumni who are at the forefront of contemporary artistic practice in Australia, some have earned international recognition for their work, such as contemporary artist Serwah Attafuah, who exhibited work at Amsterdam's Felix Meritis last year and is in the Biennale of Sydney this year.

Parramatta Late-Night Trading DCP

City of Parramatta Council endorsed the Parramatta Late Night Trading Development Control Plan (DCP) to form Part 10 of the Parramatta Development Control Plan 2023 at its meeting on 24 June 2024.

The Late-Night Trading DCP controls will apply to the Parramatta City Centre and provide detailed guidelines for business seeking to trade in the evening and early morning hours. The DCP also requires new sensitive receiver developments (such as new residential or office buildings) within the Parramatta City Centre to include appropriate

noise amelioration measures to ensure that future residents or workers will not be affected by late night trading noise.

The Late-Night Trading DCP is consistent with Council's strategic documents that set out Council's vision for Parramatta City Centre as a future 24-hour night time economy promoting a safe, thriving, and diverse range of opportunities to serve local residents and visitors with appropriate safeguards to monitor and balance amenity considerations.

Parramatta's World Cup Live Site

Parramatta turned into fan central for 31 days across July and August for one of the biggest sports events in Sydney in 2023 – the 2023 FIFA Women's World Cup. During this time a sold-out crowd of 80,000 descended on Sydney Olympic

Park for the Women's World Cup semi-final with thousands more watching the action at live sites across the Parramatta CBD including two sites at Parramatta Square and one at Centenary Square.

Supporting Social Enterprise

The Good Gift Guide and markets celebrate and promote businesses that make a difference for communities and the environment. Launched just before Christmas, the guide and markets featured local enterprises, fair trade, ethical purchasing and environmentally friendly businesses, indigenous owned/founded businesses, charities and more.

The markets were held in Centenary Square on Social Enterprise Day and featured stalls from the guide, making it easy to find unique gifts that make a positive difference to the world.



Civic Link

The \$21 million project, part funded by the NSW Government will be Parramatta's grand promenade, providing a vibrant green pedestrian spine running from Parramatta Square to the Parramatta River.

It will connect the railway and light rail with the future Sydney Metrowest, and the Powerhouse Parramatta Museum at the river's edge. It will be an iconic pedestrian boulevard, a place to gather, celebrate culture and enjoy nature.

Designs for the city-shaping project reflect Parramatta's deep connection to the river and incorporate the use of innovative infrastructure with integrated lighting, CCTV, environmental sensors, dynamic signage, public WIFI and recharge points. TStage 1 was exhibited in early 2024 and expected to be completed in 2027.

Lake Parramatta Swimming Area Upgrade

Lake Parramatta is one of the most significant and beautiful bushland remnants in Western Sydney, with a diversity of native flora and fauna. The upgrade to the Lake Parramatta swimming area includes improved amenity, access and general visitor safety.

A critical component of this upgrade was the construction of an underwater retaining wall. To avoid draining the lake and impacting the local environment, Council utilised innovative technology to reduce costs, risk and impacts to the environment including:

- > Single beam echo sounder bathymetry and static marine seismic refraction to measure the lakebed and substrate depth and underwater topography, and inform the construction material and methodology of the wall
- > Innovative construction materials including highly durable geofabric bags filled with sand and gravel that provides greater flexibility and lakebed surface traction.

Bringing People, Ideas and Tech Together at CoLAB

CoLAB was an exciting step in Parramatta's journey as a smart city. The successful program launched in October 2023, provided the opportunity to experiment with emerging technology, including virtual and augmented reality, 3D printing and AI.

The CoLAB technology lab was created in partnership by the City of Parramatta and Western Sydney University's Launch Pad technology business incubator, following community requests for more spaces for networking and collaboration. Council recently endorsed a 10-year Smart City and Innovation Strategy which will look to further promote advanced ideas and technology.



Phillip Street - Smart Street Stage 2

Council is moving forward with the second stage of upgrade works along Phillip Street, Parramatta, connecting the planned upgrades of Parramatta Wharf and Charles Street Square to the Eat Street Precinct and Bankwest Stadium. In October 2023 detailed designs were finalised, informed by community consultation and the tender process completed in early 2024.

The proposed works include the widening of the footpath on the southern side of Phillip Street between Smith Street and Charles Street to accommodate outdoor dining, as well as the installation of an 'urban forest' of mature trees and 'smart city elements' such as condition-response lighting, street furniture with built-in USB charging ports, smart irrigation, CCTV, environmental monitoring, compactor bins with sensors, digital screens and water misting.

Places to Love

The Yilabara Path in Parramatta introduced an innovative approach to urban design with its groundbreaking glow-in-the-dark ground mural, a first of its kind in the Parramatta LGA. This mural, created by First Nations artist Leanne Redpath (Watson) in collaboration with artists Tina Barahanos and Alexandra Byrne, enhances the aesthetic appeal of the path while also improving visibility and safety during nighttime hours. The glowing elements are strategically integrated into the path's design, incorporating traditional Aboriginal motifs and storytelling elements that illuminate under ambient light conditions.

This project, funded by Transport for NSW, sought to empower the local Dharug community in Indigenous-led place naming and placemaking, educating the wider community about Dharug language, culture and history. This involved working with Dharug consultants, Elders and an Aboriginal identified artist to name an unnamed lane and co-design a public artwork for the site. This transformed one of the few direct pedestrian connections between Phillip Street and the Parramatta River foreshore into a vibrant and inviting space.

Smart City and Innovation Strategy 2024–2033

Throughout 2023/24 Council continued to review the Smart City and Innovation Strategy 2024–2033. This ten-year strategy sets Council's vision for a vibrant, sustainable and connected Parramatta. Extensive consultation was undertaken with the community to provide information about the project, obtain feedback and involve them in the journey of drafting the Strategy.

City of Parramatta aims to create a culture of exploration with innovation at the centre, championing local initiatives and utilising data to make decisions about how to improve our City.



SERVICE LEVEL REVIEWS

Progress on the delivery of the service reviews council has committed to undertake, the results of those reviews and any changes made to levels of service:

In 2023/24, Council completed a service review of its Waste and Cleansing services with an aim to ensure the Business Unit is fit for purpose and continues to provide a service to the community as expected and aligns with the direction of the City's 2050 vision.

Council also undertook a review of the Regulatory Services business unit with a view to ensuring the service levels are adequate and in line with the direction set by the Parramatta 2050 vision. The review was successfully completed and presented to the Councillors in July 2024. The recommendations resulting from the review are planned to be implemented in stages, with the first stage beginning in 2024/25.

PARTICULARS OF ANY ENVIRONMENTAL UPGRADE AGREEMENTS (EUAs) ENTERED INTO BY COUNCIL

The City of Parramatta did not enter into any Environmental Upgrade Agreements (EUAs) during the 2023/24 reporting period.

STATEMENT OF ALL EXTERNAL BODIES THAT EXERCISED FUNCTIONS DELEGATED BY COUNCIL

The Independent Hearing and Assessment Panel (IHAP) was established by Council in August 2016. It was replaced on the 1 March 2018 by the Parramatta Local Planning Panel (PLPP); after the Minister for Planning mandated Local Planning Panels for the Greater Sydney Region and Wollongong. The creation of the PLPP is in accordance with section 2.17(2) of Environmental Planning and Assessment Act 1979.

In accordance with section 2.18(2) of the Environmental Planning and Assessment Act 1979, the PLPP is made up of the following 4 members:

- an approved independent person appointed as the chairperson of the panel with relevant expertise, and
- 2 other approved independent persons with relevant expertise, and a representative of the local community who is not a Councillor or mayor.

Relevant expertise refers to expertise in at least one area of planning, architecture, heritage, the environment, urban design, economics, traffic and transport, law, engineering, tourism or government and public administration.

The processing and assessment of these applications is undertaken by the staff of the City of Parramatta Council. The PLPP assumes the functions of Council as a consent authority under Part 4 of the Environmental Planning and Assessment Act 1979. As per the Ministerial Direction issued under section 9.1 of the Environmental Planning and Assessment Act 1979, the PLPP determines the following applications:

1. Conflict of interest – development for which the applicant or landowner is:

- the Council
- a Councillor
- a member of staff who is principally involved in the exercise of Council's functions under the Environmental Planning and Assessment Act 1979
- a member of parliament (either the parliament of NSW or Parliament of the Commonwealth), or
- a relative (within the meaning of the Local Government Act 1993) of a person referred to in (b) to (d) but not development for the following purposes which requires:
 - internal alterations and additions to any building that is not a heritage item
 - advertising signage
 - maintenance and restoration of a heritage item, or
 - minor building structures projecting from a building façade over public land (such as awnings, verandas, bay windows, flagpoles, pipes and services, and sun shading devices)

2. Contentious Development – development that:

- a. in the case of a Council having an approved submissions policy – is the subject of the number of submissions set by that policy, or
- b. in any other case – is the subject of 10 or more unique submissions by way of objection.

3. Departure from development standards – development that: contravenes a development standard imposed by an environmental planning instrument by more than 10% or non-numerical development standards.

4. Sensitive Development

- a. designated development

- b. development to which State Environmental Planning Policy No. 65 – Design Quality of Residential Flat Apartment Development applies and is 4 or more storeys in height
- c. development involving the demolition of a heritage item
- d. development for the purposes of a new licensed premises, that will require one of the following liquor licenses:
 - i. a club license under the Registered Clubs Act 1976, or
 - ii. a hotel (general bar) license under the Liquor Act 2007, or
 - iii. an on-license premises license for public entertainment venues under the Liquor Act 2007
- e. development for the purposes of a sex services premises and restricted premises development applications for which the developer has offered to enter into a planning agreement. Panels only deal with s. 4.55(2) modifications that meet the current LPP criteria for conflicts of interest, contentious development or departure from development standards.

Council is committed to delivering fair and equitable opportunities. In 2023/24, we continued to implement our Diversity, Equity & Inclusion Strategy which is focused on attracting, developing, and retaining diverse talent while fostering an equitable and inclusive workplace. We continue to implement and embed the principles in Council's Equal Employment Opportunity (EEO) Management Plan 2022–2025. In alignment with the EEO, Council's new premises 9 Wentworth Street has been fitted with a multi-faith room, parent room and gender-neutral toilets to help create a more inclusive workspace. Education to support an inclusive workplace has been introduced including 'Inclusive recruitment training' delivered in June 2024, and our internal run leadership development now includes an 'Inclusive Leadership' module. In partnership with Australian Disability Network we have also launched a Hidden Sunflower disability awareness eLearning.

Employee Resource Groups (ERG), sponsored by the Executive Team, continue to actively raise awareness on Gender, LGBTIQ+, Disability, Early Careers, and Veterans matters, and our First Nations ERG was launched in June to support our First Nations Strategy. - 23,300 stormwater structures (pits), and
- 74 other type stormwater assets including gross pollutant traps

Council's Stormwater Assets Long Term Capital Works Program requires significant investment to address various flood mitigation and draining improvement works in identified areas.

The initial acquisition and construction costs of any asset represent only a portion of the costs over its lifecycle. New assets require ongoing funding to operate, maintain, renew, and dispose of in the future.

The total amount of funding received during 2023/24 from the Stormwater Levy was \$2,114,323. The balance of under spent funds are returned to the externally restricted reserve.

Information on Companion Animals Management

Councils are required to include in their annual reports a detailed statement of their activities during the year relating to the management and enforcement of the Companion Animals Act 1998 (CAA), ensuring compliance with the CAA for both dogs and cats.

Educational Programs

Council's annual subsidised desexing program, in conjunction with local participating vets was run in the June/July period, however it was adversely impacted by staff shortages being experienced by local veterinarians. Subsequently Council was not able to undertake our annual Vaccination and Microchipping Day (in conjunction with the RSPCA) due to the same impacts.

However, Council was partnered with the RSPCA for the Keeping Cats Safe at Home program which focused on desexing both owned cats and colony cats to prevent unwanted litters. Through both programs we were able to desex 246 cats and 13 dogs.

Council continues to provide free pet tags and microchipping to all its residents' pets to prevent animals entering the animal holding facility and to assist with returning lost pets home.

Council maintains signage at each of its off-leash dog parks as to acceptable and unacceptable dog behaviour along with Council's contact details if users need to make reports of dog attacks or other incidents.

Council staff attended community events for various charity/ rescue groups to provide education regarding the CAA and free microchipping services. In addition, Council is continuing with free engraving of name/contact tags.

Animal Holding Procedures

Council utilised Blacktown Animal Rehoming Centre (BARC) for the last financial year to hold, release, sell, rehome or euthanise companion animals from Parramatta LGA including animals that come from both residents and Council staff. BARC has two strategies relevant to the rehoming of unclaimed animals through advertising and the sale of unclaimed animals to new owners and rehoming through a number of reputable rescue groups, which significantly reduces the number of animal's euthanised.

The euthanasia rate for rehoming dogs for the last financial year was 0%, with a total of two dogs euthanised which were either unsuitable for rehoming or a declared 'dangerous or menacing' dog. The euthanasia rate for rehoming cats was also zero with no feral or undomesticated cats entering the facility.

Council also uses its own temporary holding facility where possible for reuniting pets with their owner, therefore avoiding animals entering BARC where fees apply and, due to financial hardship, may not be claimed. Council has doubled its holding capacity at our temporary holding facility to eight kennels in response to higher capacity rates being experienced by all Animal Holding Facilities across NSW, including BARC.

Council returned 79 dogs to owners in lieu of transportation to BARC. Council has also formed working relationships with a number of reputable rescue groups for assistance in taking on kittens and other animals at high risk of not being claimed or rehomed, such as dumped/ timid/old animals. This further helps reduce the possible euthanasia rate of these at-risk animals.

REPORT ON COMPLIANCE WITH THE CARERS RECOGNITION ACT 2010 (CR ACT)

Council has provided both formal and informal support to 32 carers within Community Care Services.

Type of support provided to carers:

- Referring carers to the Carer Gateway for specific information, education, and training
- Referral to Care Finders - Care finders help people access aged care services and connect with other relevant supports in the community
- Provision of meals through Meals on Wheels
- Social support and connection for carers with other people through volunteer visitations or social inclusion group activities

- Non-accredited assistance in interpretation and translation provided to carers from a culturally and linguistically diverse background who speak little or no English
- Assistance or advocacy in situations where carers may be experiencing difficulties with navigating housing, telecommunication companies, National Disability Insurance Scheme or My Aged Care
- Information during major incidents, for example extreme heat and flooding, Council maintains contact with a person's carer or emergency contact to keep them informed of latest warnings and ensure they are safe.

Staff who are carers

Council provides a range of flexible work arrangements to enable staff to manage their work and personal responsibilities including with carer's responsibilities to better manage work and carer's responsibilities, including such as, full-time, part-time, and casual work; flexible working hours; and rostered day off systems.

Some flexible work options for staff who are carers include:

- Variation to Core Work Hours
- Part-time hours
- Flexi-time
- Time in lieu
- Rostered Days Off
- Job Sharing
- Leave without Pay
- Working from Home
- Remote Work

Council's flexible working policy supports all employees to balance work and carer's responsibilities. Taking into account operational requirements, Council also considers requests for flexibility to substantive working arrangements for carer's responsibilities on an individual basis.

COUNCIL'S DISABILITY INCLUSION ACTION PLAN REPORT

Council reported to the Department of Communities and Justice on progress of the current Disability Inclusion Plan on 30 November 2023 using the Department supplied reporting template. Council is estimated to have completed 50% of the plan as of July 2024. Actions are tracked in terms of in-progress, delayed, not started or completed, and percentage progress towards completion.

Many actions continue to be in-progress and focus on establishing new systems and procedures within Council and services to the community.

As of June 1, 2024, current completed and significantly progressed projects include:

- Creation of original images containing diverse people with disability participating in community life as equal community members around Parramatta, to be used across all Council communication products and channels.
- Staff Autism information sessions and an Autism-friendly site assessment of the Parramatta Aquatic Centre, leading to a plan to address recommendations, under a partnership with Autism Spectrum Australia (ASPECT) to increase understanding of Autism and to create Autism friendly spaces and services.
- Free trials of Parramatta Aquatic Centre facilities have been provided to raise knowledge and confidence in people with disability to access Centre facilities and programs.
- Integrating Auslan interpreted Story Time sessions for children into Library programming.
- Increasing digital wayfinding kiosks in the Parramatta CBD, improving access for the sight impaired and other disabilities.
- An access audit of the new civic building PHIVE, along with commencing delivery on a plan to address the audit's recommendations.
- Delivery of Universal Design information sessions to staff across diverse teams involved in planning, design, and service delivery, to build up knowledge across the organisation.
- The development of an accessible playground framework, that along with an access audit completed for all playgrounds, has been used to identify accessible playgrounds in the LGA and will inform planning and future works.
- Continued Membership of the Australian Disability Network, supporting development of accessible recruitment and employment policies and practices at Council, and to be used to develop a Workplace Adjustment Policy in the coming year.
- Development and trial of a new record keeping system structured around a best practice framework, for the NDIS Coordination service to track and demonstrate progress towards client personal goals and in addressing barriers in accessing supports. This trial has clarified the needs and structure for a new information management system proposed to be developed over the coming year.
- Increasing the option for making verbal submissions across community consultation processes calling for public submissions.
- A progress and reporting framework has been developed, and annual (end of Calendar year) progress is reported to the Community through Council's DIAP webpage, along with graphics to explain the outcomes framework guiding action delivery.

As recommended by Autism Spectrum Australia, Council is also aiming for multiple sites to become officially recognised as Sunflower Friendly within the coming year, under the Hidden Disability Sunflower program that aims for improved customer service for people with hidden disabilities. Training of staff at key service delivery sites is to commence in July 2024. Actions relating to this will be added to the current DIAP for each site.

PARTICULARS OF COMPLIANCE WITH AND EFFECT OF PLANNING AGREEMENTS IN FORCE DURING THE YEAR

A voluntary planning agreement (VPA) is an agreement entered into by a planning authority (such as the City of Parramatta) and a developer. They typically accompany a development application or a planning proposal. Under a VPA a developer agrees to provide or fund:

- public amenities,
- affordable housing,
- open space, public domain embellishments or other infrastructure, or
- some other benefit. Contributions can be made through:
 - the dedication of land,
 - monetary contributions,
 - construction of infrastructure, and/or
 - provision of materials for public benefit and/or use.

A VPA cannot be entered into unless it has been publicly exhibited along with an explanatory note for at least 28 days.

RECOVERY AND THREAT ABATEMENT PLANS

In regard to Section 220ZT (2) of the Fisheries Management Act 1994, the relevant Recovery and Threat Abatement Plan relative to City of Parramatta is the removal of large woody debris (LWD) from NSW rivers or streams.

City of Parramatta manages approximately 105km's of natural waterways and as a general rule does not remove LWD from those waterways.

DETAILS OF INSPECTIONS OF PRIVATE SWIMMING POOLS RECOVERY

A total of 106 applications were received for Council to inspect private swimming pools in 2023/24. As a result of these inspections, 58% were issued with a Swimming Pool Compliance Certificate and 22% were issued with a Swimming Pool Non-Compliance certificate. The remainder are still under review.

Council also receives requests to inspect multi-dwelling pools open to and used by the public. These include Hotels, Strata Buildings etc., a total of 21 pools were inspected.
