Councillor Henry Green raised concerns regarding the introduction of the cycleway in Alfred Street citing that in the past, Alfred Street has served an important function in diverting traffic from James Ruse Drive when there are traffic incidents. An example of this includes a recent chemical spill in James Ruse Drive which caused traffic lanes in both directions to be closed. Due to this, and the existing volume of traffic in Alfred Street, Councillor Green believed that the footprint of the cycleway was too large and would result in the road carriageway and parking lane to become narrow and not suitable for the traffic function of the road.				

Further to this, Councillor Green advised the Committee that residents have reported they will find it difficult to leave their driveways with the cycleway in place. Councillor Noack advised that he had a meeting with residents where they raised similar issues and opposed the installation of the cycleway.

Richard Searle of City of Parramatta Council advised the Committee that Council has already approved both Stage 1 and Stage 2 of the Alfred Street Cycleway and noted that sections of Stage 1 of the cycleway between Eleanor Street and Parramatta Road had already been completed or nearing completion. Accordingly, the matter currently for consideration of the Committee is regarding modifications to the existing approved designs. For clarity, these include:

1. Changes to the bus stops between Eleanor Street and Weston Street
2. Changes to parking between Prospect Street and Virginia Street
3. Proposed left turn restriction at Hassall Street and Alfred Street intersections

Councillor Green clarified that in regard to items currently being considered by the Traffic Committee, he only opposed the removal of the parking spaces to install three large street trees and not the proposed changes to the bus stops or installation of turning restrictions. Accordingly, the Committee resolved to remove reference to the removal of parking from the recommendation.

<p>Richard Searle asked the Committee if TfNSW and Parramatta PAC would consider the event as a Class 3 Special Event as per the TfNSW Guide to Traffic and Transport Management for Special Events where concurrence is only required from the Police and not through the Traffic Committee Process.</p> <p>Sergeant Jack Makhoul from Parramatta PAC advised that due to the potential impact for this event and the possible high attendance numbers, this event may need to be classed as a Class 2 Special Event. Furthermore, he advised that due to the narrow carriageway of Ada Street, the space to host the event may be too small for the number of attendees and that Hostile Vehicle Mitigation devices may not be able to be installed correctly in this location as sufficient clearances from intersections cannot be achieved. Both the representative from TfNSW and Parramatta PAC reiterated previous advice being that a 3 month lead time is required to host Class 2 Special Events.</p> <p>That the information regarding the proposed special event be received and noted.</p>
