The Chairperson, Councillor Noack commended Council staff on obtaining detail design approval for the proposed traffic signals at the intersection of Hill Road and Bennelong Parkway, Wentworth Point.

Councillor Noack requested more information as to the status of the proposed roundabout at the intersection of Hill Road and Burroway Road, Wentworth Point. It was noted that design aspects of the proposal are currently being considered including drainage, pavement, and the raised pedestrian crossing on the north side of the intersection.
