1. INTRODUCTION

In March 2022, City of Parramatta Council invited the community to comment on a proposal to create a dog off-leash area in West Epping Park.

In consideration of the adopted West Epping Park Masterplan, and in response to ongoing community interest including a petition, the Open Space team developed a Concept Plan for the proposed offleash area and invited feedback via an online survey on Participate Parramatta, email or post.

The objectives of the consultation were:

- To seek feedback and gauge support from local residents and park users for the proposed dog off-leash area identified in the West Epping Park Masterplan
- To inform the community regarding proposed changes within the park prior to a Council decision

2. EXECUTIVE SUMMARY

The proposal for the **West Epping Park Dog Off-Leash Area** received 2050 views on Participate Parramatta and 221 contributions during the four-week consultation¹.

Overall, community feedback was positive with 81.9% supporting of the proposed dog off-leash area.

This result is notable due to the higher than average submission rate online (12.4%) and higher than average engagement rate generated by the paid social media campaign.

Among the 221 residents who completed the survey:

- 81.9% support the proposal
- 73% were frequent users of the park (1x week or more)
- 75% were residents of Epping (68.7%) and Carlingford (6.3%)
- 69.7% said they currently own a dog

The most important facilities named were:

Facility	Score (Ranking score)
1. Fencing	6.99
2. Waste bags/bins	5.91
3. Water	4.66
4. Shade	3.7
5. Seating	2.66
6. Signage	2.1
7. Lighting	1.94
8. Agility equipment	1.41

Fencing was a high priority for respondents with 98.2% preferring the dog off-leash area to be fenced.

If people indicated they **were opposed or were unsure** about an off-leash area, they could provide a reason and 34/221 chose to comment. The themes most frequently mentioned were:

- Perceived danger to children (12 mentions)
- The park's proximity to West Epping Public School (5 mentions)
- The loss of space for exercise/recreation (5 mentions).

All respondents were invited to make further comments and suggestions, with 118/221 providing

answers. Figure 2.1 illustrates the most frequently mentioned themes including:

- Specific mention of the local need for the off-leash area (28 mentions)
- Comments about the essential/non-essential features within the off-leash area (21 mentions)
- General approval (17 mentions)
- Opposition due to perceived danger was the next most frequently mentioned comment (13 mentions)


Comments outlining criticism of the concept plan focused on:

- Small and large dogs should be separated (7 mentions)
- Area needs to be larger (13 mentions)

Two negative comments were from adjoining property owners, each stating their opposition to the proposal.

Overall, most of the comments and suggestions were from people supporting the proposal (94/118 comments).





3. ENGAGEMENT EVALUATION

Several methods were used to promote awareness and engagement in the Epping community and West Epping neighbourhood. The engagement was promoted for four weeks from 9am Monday 28 February – 5pm Monday 28 March 2022. Overall, the opportunity to share feedback was presented on 33,893 occasions, culminating in 2,050 views of the project page and 221 engagements (survey submissions).

Home / Proposed West Epping Park Dog Off-leash Area

Dogs are required to be on a lead when in a public park or reserve unless it has been declared as an 'off-leash' area. Council currently provides a number of 'off-leash' exercise areas in recognition of the benefits for the health and well-being of dogs and their owners.

Consultation on the proposal for a Dog Off-Leash Area at West Epping Park has now closed. Thank you to everyone who contributed. Please **follow this page** for project updates!

A growing proportion of our residents are living in apartments and townhouses without access to large backyards. Research also indicates rising household rates of dog ownership, which together are increasing the demand for off-leash areas to provide safe opportunities for dog exercise and socialisation. The **Epping Ward currently lacks a dedicated dog off-leash area**, with the closest being located in adjoining local government areas.

The adopted **West Epping Master Plan** identifies a potential dog off-leash area at **Grant Close**, **Epping**. This open grassed area is free of obstacles to maximise running space and has clear sight lines to assist dog owners maintain effective control.


3.2. Social Media Campaign

- Overall, the campaign performed well achieving a \$0.26 CPC.
- Frequency was at 2.27 which is on par with what we aim to achieve, indicating the budget for audience size was appropriate.
- Interestingly the creative using the park plan was the preferred content type for the platform when optimisations were carried out; this is an insight to test further in future campaigns.
- CTR of 2.65% exceeded the CoP benchmark showing positive interest from the community.

3.3. PARTICIPATE Parramatta

The Proposed West Epping Park Dog Off-Leash Area engagement campaign directed community members to the Participate Parramatta website and ran from 28 February – 28 March 2022. The project page (Figure 3.2 & 3.3) was viewed 2,050 times and generated 221 contributions.

Engagement highlights:

- 1,429 people (94%) were new visitors to Participate Parramatta
- 62.7% were female, 33.1% male and 4.5% preferred not to answer
- 68.7% were located in Epping
- 221 submitted a contribution
- 139 followed the project
- The concept plan was downloaded 54 times







4. KEY FINDINGS

The survey captured the following answers to questions about use of the park and desirable park features.

Question 1: How often do you visit West Epping Park? Answered: 221 (100%)






This was a conditional question, which prompted people who answered no or neutral in Question 3 to share more detail. There were 34 responses overall to this question. Some responses mention more than one theme which are counted in the table below.

Full comments are in the Appendix. Below are key themes with an example from the comments.

Key theme	Mentions	Example
Danger to children	12	Lots of children having activities in the park, and I have seen dog attacking young child there, strongly against the proposal.
Loss of space for general recreation	5	A dedicated dog fenced area would be good for dogs and dog owners. However for non dog owners that mean we lost an area of relax and exercise.
Proximity to school	5	The park is so close to Epping West School and West Epping preschool. It's not safe for kids to walk around there with dogs.
Risk	4	There were big dogs around which were not friendly and many of us do not feel safe even there is fence.



Overall, the majority of people who provided comments / suggestions were supportive (95 of 118) while 23 of 118 were opposed/unsure.

	1	While most dog owners are responsible Epping is home to many families with children and elderly residents whom use the park for exercise. Many dog owners simply don't follow the rules and take their dogs off leash. Epping west park caters to many young kids and this is a public liability to mix these young children with potential dog injuries. Having a totally separate dedicated dog park away from epping west park perhaps in the Cheltenham area near the M2 or mobbs lane would be more suitable. People travel from afar to use epping west. It houses cricket, soccer sports and tennis and the dog park will reduce the facilities of families, create chaos, traffic, waste etc. I would very much oppose the dog park

Agility equipment is a great idea but may also restrict the space available for dogs to socialise.
1		Having a path to walk around inside the fenced area that is accessible for all (eg wheelchair, scooter), and usable in all weather may also encourage owners to walk and not stand/ sit around chatting to each other and ignoring their dogs (that is when fights start or poos are missed). Trees and plants are not only important for shade but provide enrichment to the dogs, sniffing is a highly beneficial and calming activity and uses they instincts. Maybe research some more on what plants are safe andmight be good to plant, other councils have done some work on this. Would be great to see some equipment included like you have at Silverwater, but the park on the map looks tiny so may not be appropriate (I'm usually at Cowell's Lane but like to visit other off leash areas at times for variety). On a separate note, a safe dog beach within the parramatta council would be awesome, it is so hot in this area.
